Council trading standard teams have recently seized fake vodka with high levels of methanol, which is also used to make anti-freeze and can lead to blindness. Industrial solvents have also been found in the bottles.

One shopkeeper was fined £16,000 after Surrey County Council seized bottles of fake Glen's Vodka which was found to contain 235 times more methanol than the legal limit allowed. It comes after the Telegraph reported last week how some fake booze seized from Coventry shops was found to contain solvent Propan-2-ol.
